

**A RESOLUTION AMENDING THE USER CHARGE SYSTEM FOR
WATER SUPPLY SYSTEM**

Minutes of a regular board meeting of the Township Board of the Township of Forsyth, County of Marquette, State of Michigan held in the Community Center on July 28, 2016, at 6:30 o'clock P. M., Eastern Daylight Time.

The following preamble and resolution were offered by Member Trustee Adams and supported by Member Treasurer Roberts

WHEREAS, the Township Board of the Township of Forsyth, County of Marquette, State of Michigan (the "Township"), has established a user charge system pursuant to Ordinance No. 3 duly adopted by the Township Board on May 15, 1956, as amended (the "Ordinance"), in accordance with the Revenue Bond Act, Act 94, Public Acts of Michigan, 1933, as amended, and other applicable statutes of the State of Michigan, for the use of the Township's water supply system (the "System"); and

WHEREAS, the Ordinance provides that the Township Board shall from time to time by resolution fix and revise rates, fees and charges for connection to and use of the System; and

WHEREAS, the Township Board hereby determines that it is necessary for the public health, safety, welfare, and continued operation of the System, that certain rates, fees and charges for use of the System be revised.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Amendment to User Charge System. Commencing September 1, 2016, the following rates, fees, and charges for connection to and use of the System shall be effective:

Description	Fee
Monthly Base Water Service Charge (Unmetered users)	\$42.50 per REU
Monthly Base Water Service Charge (Metered users)	\$25.00 to active customers for 0 to 2,000 gallons \$10.00 per 1,000 gallons above 2,000 gallons
Readiness to Serve Charge	\$20.00 For Shutoff Customers, \$0 for active
Debt Service charge	\$ <u>N/A</u>
Water Connection Charge	\$ <u>N/A</u> per REU
Turn-on/Turn-off Fee	\$20.00
Bulk Water Fee	\$10.00 per 1000 gallons
Fire Hydrant Rental Fee	\$ <u>250</u> per hydrant payable in [quarterly] installments
Application Fee for Water Service	\$ <u>N/A</u>
Water Meter Testing Fee	\$ <u>N/A</u>
Water Restoration Charge	\$ <u>N/A</u>

2. No Other Changes. Except as specifically set forth herein, all other rates, fees and charges for connection to and use of the System established heretofore are hereby ratified, confirmed and approved, and shall remain unchanged and in full force and effect.

3. Repealer. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same hereby are rescinded.


